CHAPTER V

CONCLUSION AND SUGGESTION

This chapter encompasses conclusion and suggestion. The conclusion refers to the result of analysis and the suggestion relates to writer's ideas after concluding the analysis.

A. Conclusion

This research aimed to find the modalities in *The Most Beautiful Moment in Life the Notes 1 English Version* written by Big Hit Entertainment which covered the kinds of modal verbs, functions and the meaning of modality. The writer used qualitative method for analyzing the data.

The writer found three kinds of modality namely epistemic, deontic and dynamic modality. Epistemic, deontic and dynamic modality can be applied in both positive and negative forms. Those kinds of modality also have different functions such as possibility, necessity, probability, ability and obligation. The result of this research found modal verbs categorized as epistemic modality named *can* expressed *possibility* (1 data or 3.3%), *must* expressed *probability* (7 data or 23.3%), *would* expressed *possibility* (3 data or 10.3%), *will* expressed *certainty* (1 data or 3.3%), and *might* express *probability* and *possibility* (2 data or 6.6%). Modal verbs categorized as deontic modalities found are *must* expressed *obligation* (1 data or 3.3%) and *should* expressed *obligation* (4 data or 13.3%). Furthermore, the writer

found modal verbs categorized as dynamic modality named *can* expressed *ability* (1 data or 3.3%) and *could* expressed *ability* (10 data or 33.3%).

The writer concluded that modal verbs *could* as *dynamic modality* expressed about the speaker *ability* was the most frequent kind of modal verbs that used in *The Most Beautiful Moment in Life the Notes 1 English Version* written by Big Hit Entertainment.

The most important point of this research is that modalities can help the readers to understand context of the sentence and ambiguous items. Moreover, this research showed the use of modality and its concrete meaning based on theory. Modality is a resource speakers and writers used when they expressed their judgment, knowledge or ideas about possibility, probability, and ability or obligation.

B. Suggestion

After analyzing this thesis, the writer found some conclusion about the strength and the weakness of this study. In the last chapter, the writer would like to give several suggestions that are expected to be useful in the future.

For an English Learners, it is important to know the meaning of modal verbs since it is helpful to comprehend the purpose of speakers or writers. The writer suggests the English Learners to study not only the structure of sentence but also the meaning of it to improve their competence in learning English.

For the next researcher, the writer suggests that the next research could complete this research especially for the theoretical about modal verbs, kinds of modality and its functions.

The last is for the campus, the writer suggests that the library could add more books related to semantics, modal verbs, and others related to modality to facilitate the students who want to learn more about modal verbs and modality.
