CHAPTER I

A. Background of the Research

In the novel, the author describes fictional characters and events, usually in the form of a sequential story. Nowadays, the novel not only tells about the young people's love relationship, additionally the moral crisis, education, and other social life that is shared by the author and finally it can be received by the readers' feelings. Novels have intrinsic elements such as plot, conflict, theme, point of view, setting, and character.

Novel has so many characters depicted with more detail and the greater care from the author's imagination thereby moving beyond the classical epic whose main character functions primarily as the embodiment of abstract. In types of conflict, a story may deal with conflict with a single person, a conflict among people, a conflict between people and society, between people and nature, and so on. In this research the writer intends to use the novel as an object.

Conflict always happens in every aspect of human life. The role of conflict as an integral factor in shaping social conditions and the dynamics of social life. In fact, people who read a novel or watch a movie often find the conflict or potentially conflict situations among individuals, social groups, political parties, and so forth. Social conflict is struggle over values or claims to status, power, and scarce resources, in which the aims of the conflict groups are not only to gain the desired values, but also to neutralize, injure, or eliminate rivals.

The writer has two reasons why she is interested in analyzing the novel. First, that novel is a media of communication and education, it is also a replica of world life. Second, the novel is very interesting to be analyzed because it not only makes the writer understand the story from the text but also from what the author shared. Furthermore, the writer takes the main character's social conflict because it is very interesting to be analyzed and also the writer assumes that social conflict has power to affect human behavior, way of thinking, attitude, and their relationships with other character because social conflict it is closely related with human daily life and readers can learn from it when they face same problem.

The source of the data in this study was the novel Pride and Prejudice by Jane Austen, while the object of research was social conflict in the novel Pride and Prejudice by Jane Austen, Pride and Prejudice is a novel of manners of Jane Austen, first published in 1813. The story follows the main character, Elizabeth Bennet, as she deals with issues of manners, upbringing, morality, education and marriage in the society of the landed gentry of the

British Regency. Elizabeth is the second of five daughters out of a country gentleman living near the fictional town of Meryton in Hertfordshire, near London.

Jane Austen is the greatest English novelist. She was born at Steventon in Hampshire, a small town in southwest England where her father rector of the church. Jane Austen's career belongs chronologically to the romantic period but she is not only writing about romance stories and is concerned with only two people and their romance, but also her focus about family circle, and society. Her writing style, while characteristic of the 18th and early 19th centuries. It makes the young readers difficult because of her long, complex sentences.

Most of Jane Austen's novel are about social class structure, sexual discrimination, cultural roles for men versus women, the inequality of freedom for the sexes, financial opportunities, lower class and upper class. The novels also show about the mobility of the professional classes, the tremendous difficulties faced by women failed to marry well, the seamier side of life, adulterous elopements and love children.

The first novel Jane Austen is *Sense in Sensibility* was published in 1795. *Pride and Prejudice* in 1796, *Northanger Abbey* in 1797, from the early novels created by Jane Austen, people can see her perfecting skill about social comedy. The beginning of 1811 she published *Mansfield Park*, *Emma* in 1814, and *Persuasion* in 1815. Jane Austen published most of her literary work at Chawton, a small village only a few miles away from her birthplace. From the explanation about Jane Austen and her literary work above, the writer chose the Pride and Prejudice Novel as an object. Because the writer assumes that the novel is a great to read. And from the Pride and Prejudice novel there are so many social issues and feminine cases it is shows about love, pride and off course social differences and how this affected England in this Phrase in marriage and love. That all makes the writer interesting to analyze.

In this research, the writer presents the data analysis based on the types of social conflict in the Pride and Prejudice Novel by Jane Austen. The writer analyzes kinds of social conflict in the Pride and Prejudice Novel by Jane Austen by using Lewis Coser perspective. Lewis Coser was born in Berlin, Germany, in 1913. His family moved to Paris in 1933 where he studied literature and sociology at the Sorbonne. Because of his German heritage, Coser was arrested and interned by the French government near the beginning of World War II. He later was able to get political asylum in the United States and arrived in New York in 1941.

Coser did his Ph.D. work at Columbia University, where he studied under Robert K. Merton. His dissertation, The Functions of Social Conflict, took conflict theory in a new direction and was later named as one of the bestselling sociology books of the twentieth century by the journal Contemporary Sociology. Coser also authored Masters of Sociological Thought, which became one of the most influential sociological theory books in the English language. In addition, Coser established the Department of Sociology at Brandeis University; founded Dissent magazine; served as president of the American Sociological Association (1975), the Society for the Study of Social Problems, and the Easter Sociological Association (1983); and is honored annually through the American Sociological Association's Lewis A. Coser Award for Theoretical Agenda-Setting. Coser died in July of 2003. Coser after all was a conflict theorist who was influenced by George Simmel, Marx, Weber and Ralf Dahrendorf and so on.

B. Questions and Scopes of the Research

1. Question of the Research

There are some problems occurred in this novel, but the writer only restricts analysis to the social conflict. The writer gets two things that become the problems of this study. Those are the kinds and the causes of social conflict happen in the novel. Based on the background of the research above, the writer problem in this study is:
