

CHAPTER I

INTRODUCTION

A. Background of the Research

Literature works provide insight and context to all societies in the world. As one example of a literary work, there is no doubt that prose fiction is the most popular and widely consumed literary genre. Prose fiction is presented in the form of prose and is an imaginative art which means it is a product of the writer's imagination. In prose fiction, the writer tells a fictional story to their readers to educate or entertain or even do both. It will inspire, confuse, frighten, and concern us with new ideas. It can help us see ourselves and our world in new and interesting ways.

From time to time, fiction works well. The elements that make up a work of fiction have increasingly high artistic value so that the work of fiction can be enjoyed with different beauty. Fiction is built by elements that make it a real literary work. Elements in fiction are the most important things in fiction because every element represents a different explanation and interpretation of what is the meaning that the author wants to deliver to the readers. Every element in fiction also helps the writers to develop a story and increase the reader's enjoyment and understanding of different literary pieces.

According to (Kennedy and Gioia, 2010) there are 7 elements of fiction, plot, point of view, characters, setting, tone and style, theme, and symbol (p. 24).

Among the seven elements, the symbol is one of the most incredibly significant facets of fictional works that enable authors to compress much meaning into a short space. This makes the symbol something that must exist in a work of fiction. (DiYanni, 2000) state that symbols in fiction are simply objects, actions, or events that convey extends beyond their literal meaning (p. 75). sometimes, inanimate objects are the representations we encounter in fictional work, but other objects like persons, situations, locations, characters, sometimes even a part of a character's body or an attribute may convey symbolic meaning. They generally do not stand for one meaning, not for definite, because they point, they hint, and they cast long shadows. Symbol exists to represents something else and to offer a different meaning that is much deeper and more significant.

Symbolism allows writers to communicate big ideas efficiently and artfully. The author can convey something to their readers in a poetic way, instead of saying it plainly. To illustrate, where a male character is very happy to hug his woman because he feels happy, safe, and peaceful, the writer does not use flat sentences like "I'm happy when I hug you because I feel peaceful" but the writer can use symbols to express it into "I was like in the clear blue

sky when I hugged you". The phrase 'clear blue sky' symbolizes happiness and peace, it is appropriate to describe the feeling that is being felt by the male character. The expressions feel more beautiful and have a deeper meaning. Symbolism is often used in literature to paint colorful scenes. It affords the writer artistic expression that supersedes bland writing. Like the previous example, the reader will wonder why the author says 'clear blue sky' then the reader will use their imagination to interpret the meaning of 'clear blue sky' related to 'peace and happiness'.

Of course, the function of symbolism does not only for the author but also the reader that will interpret and help them to understand literary works. Symbolism in literature evokes curiosity in readers as they have an opportunity to gain insight into the mind of the writer on how he sees the world, and how he thinks about specific objects and behavior with wider implications. Maybe there are those readers who think symbolism can be overdone or run into the round but symbolism that handled well can be added touch that just might take the story stand out and be remembered years later.

Symbolism can be applied in poetry, prose, and plays, as well as in all genres of literature. A novella is a narrative prose fiction work that is longer than a short story but shorter than a novel. Novellas are more often focused on the personal and emotional development of one character rather than on

problems of a large scale. An insight into a specific character, circumstance, or plot line may be provided by a novel. A story may deserve its attention but it doesn't fit into any of the other categories altogether. A novella is not a short story but a work of fiction in its own right, with its focus, pitch, and direction. Many novellas contain a concrete symbol which is the steady point, as it were, at the heart of the narrative. So, the writer determines to choose the novella as the object of this research.

The Little Prince is one of the fantasy novellas. This novella was first published in English and French in the USA in April 1943, written by French aristocrat, writer, and pilot Antoine de Saint-Exupéry. The story follows a little boy who traveled the universe gaining wisdom. He left his small planet to visit various planets in space, understanding adult behavior vagaries through a series of remarkable experiences. His odyssey began on a trip to Earth and other adventures. The novella has been translated into 361 languages and dialects and has sold some 200 million copies worldwide, making it one of the best-selling books in publishing history.

Besides its theme as a book for children, The Little Prince makes insightful observations about life and human nature. It also addresses themes of loneliness, friendship, love, and loss. Through the written style that is like a children's book, this novella looks ordinary but has a deep meaning. The Little

Prince teaches us that adults need to be told more than children of the homilies and the plain truths of what counts and what does not matter in life. The most fascinating feature of this book is the fact that the author's writing style uses symbols to deliver his message to adults. The author's style may sound childish but his way to convey symbols has significant meaning when people see it differently. That is why I decided to choose symbolism in The Little Prince's novella to be the object of analysis in this research.

Based on the consideration above and supported by Kennedy and Gioia's theory, the writer carries out research on The Analysis of Symbolism Found in Novella The Little Prince by Antoine De Saint – Exupéry.

B. Questions and Scope of the Research

D. Operational Definition

1. Literature

Prose fiction consists of many sub-genres. Some of these are usually defined quite simply by length. The main categories are the novel and the short story. A novella is a narrative prose fiction work that is longer than a short story but shorter than a novel. The novella is a part of a novel, it is called a short novel because the novella consists of at least 17.500 words but under 50.000 words. Novella focused on just one or two characters and has room to reveal in greater fullness and depth.
