CONCLUSION AND SUGGESTION

In this chapter are include conclusion and suggestion of the research. After analyzes the words of contain of metonymy in the newspaper as a research topic, it has some conclusion in this research.

A. Conclusion

The writer finally made conclusions the analysis of metonymy on political issues in the newspaper “*The Jakarta Post*” from all chapter. After analyzing the research about the meaning of words contain metonymy, it has been concluded some conclusion based on the data of the research as follows:

1. The data have been analyzed, from “*The Jakarta Post*” found 24 data the meaning of word contain metonymy divided into 7 conceptual mapping.
2. Metonymy which found mostly in the kinds of conceptual mapping is Institution for People Responsible have 9 data (40%).
3. Metonymy which found lower in the kinds of conceptual mapping is *Producer for Product* have 0 data (0%).
4. News can not be separated from cognitive language especially metonymy on the political issues especially in the newspaper contain the way of cognitive process.

5. Analyzes the research have different expression metonymy accordance the sentence which found in the “*The Jakarta Post*”.
6. More information about social life message in the daily communication in the newspaper.
