And the first version in English is entitled Brut, a poem by Layamon. Middle English poem compiled and recast by English priest Layamon. Enlarged section of the life and exploits of King Arthur, But among Arthur's stories, the one that stands out the most is Morte d'Arthur.

Le Morte D'Arthur considered the first novel in the English language, the first in western literature, and the most comprehensive account of the Arthurian Legend. Malory wrote the book while in prison for various crimes. He died in 1471 after completing the arrangement, and rewriting the original Latin, French. And English sources of the tales of King Arthur and the knights of round table. These he linked together under the title Morde d' Arthur, work that stands as the last great collection of medieval romances. Early sources indicate that King Arthur and his knights, Galahad, Ga wain, and the others were not originally the romantic figures that appear in Malory's story. These heroes came into Norman minstrelsy from twelfth Century poetic accounts.

Thomas Malori's work for the first English novel published by William Caxton in 1485 Morte d'arthut in the British Library, London. King Arthur of England is based on Celtic folklore and has almost no historical

basis. The Round Table was not an ordinary military and political alliance, but the round table here was created to discuss the sharing of ideas between Arthur and the knights. it describes an ideal aristocratic brotherhood. His knights advanced to manifest their abilities of themselves through feats of weapons and manners. Their adventures were unexpected, but they both represented honorable knights. Honorable knighthood is their ideal, courage, courtesy, and service to the people.

The story of King Arthur has been widely adopted into novels, theatrical acts, and films. On this occasion, the writer would like to analyze the Representation of leadership of the main character in "King Arthur" 2004 movie.
