In 1841, two con men offered him a lucrative job playing fiddle in a circus, so he traveled with them to Washington, D.C., where he was drugged, kidnapped, and sold as a slave into Louisiana's Red River region. For the next twelve years, he was the human property of several different slave masters, with the majority of his time spent as a slave. Edwin Epps, a cruel southern planter, owned them. Northup was finally set free in January 1853 by Northern friends who came to his aid. He returned to his family in New York.

This book really represents the slavery that happened to Northup as other common slavery experience that happened during that time of the period. From start to finish, it all shows the time, places that happened, people who experienced or performed, and some other practices that happened, sometimes some other excessive details that happened to Northup's story throughout his writing. On the book he detailed what are the things that happened to him and how he warned the future generations what is the morals and cost of slavery from everyone's involvement. The slave's themselves is degraded. Made some of the victims suffers from cruel physical robbery and spiritually to the riches.

There's one simple data of the research that the writer found on the novel itself by Solomon Northup himself, from the page 44 he stated "I was seized and roughly stripped of my clothing as soon as these formidable whips appeared. As previously stated, my feet were firmly planted on the floor. Radburn drew me over the bench, face down, and planted his heavy foot on the fetters, between my wrists, painfully holding them to the floor. Burch began beating me with his paddle. My naked body was subjected to blow after blow. When his unyielding arm became tired." From this we can see that he was blatantly undressed and beaten by these people because he's once a slave and as a people of colored, where this settlement's still matters in that era even when he is a free-man himself.
