The songwriters created a song with beautiful lyrics that chose specific words to present the image. Some composers refrain from using familiar words when writing lyrics because it does not attract the listener to imagine and convey a message between the songs. Depending on the sort of meaning being employed, people communicate in a broad variety of ways. Connotative meaning is one of the meanings that frequently leads to widespread misunderstandings.

A word connotative meaning is its implied meaning. When words carry a particular emotional significance, they are said to have connotative meaning. People use language to express emotions in addition to ideas, views, and thoughts. These feelings will be expressed through language; it's possible that the same words are used, but because the language carries feelings, the words spoken have connotative meanings. Figurative language refers to emotive words with that connotative sense. Figurative language is inseparable from the writer's technical ways of expressing, reflecting, and describing the lyrics.

Lyrics are the words of a song that contain messages and deeper meanings. The song texts or lyrics serve as both a compliment to the music as well as an essential component of the musical parts. By singing the song, listeners may sense the song's rhythm, melody, harmony, and singer's voice, which helps them to comprehend the meaning of the words. Along with that, listeners usually listen to some songs that suit their hearts. Writers and performers can utilize lyrics to convey their sentiments to listeners through a song.

Meghan Elizabeth Trainor (born December 22, 1993) is an American singer-songwriter and television personality. She rose to prominence after signing with Epic Records in 2014 and releasing her debut single "All About That Bass", which reached number one on the U.S. Billboard Hot 100 chart and sold 11 million copies worldwide. Trainor has released five studio albums with the label and has received various accolades, including the 2016 Grammy Award for Best New Artist.

Trainor became interested in music at a young age; she wrote, recorded, and produced three independently released acoustic albums, Meghan Trainor (2009), I'll Sing with You, and Only 17 (2010). She began writing and producing songs for other artists in 2013. In 2015, Trainor released her pop and hip hop major-label debut studio album, Title, which included the top-10 singles "Lips Are Movin" and "Like I'm Gonna Lose You"; it debuted at number one on the U.S. Billboard 200. The single "No" led her follow-up album, the R&B album Thank You (2016), both of which reached number three on the respective charts. Trainor created her third album with Epic, the electronic dance music-influenced Treat Myself (2020), as an attempt to adapt to ongoing musical trends. She followed

this with the holiday album A Very Trainor Christmas later that year. Trainor's fifth studio album, Takin' It Back, was released on October 21, 2022, with its single "Made You Look" reaching the top five in many countries, including the UK, Ireland, Australia and New Zealand.

3. Kinds of Figurative Language

6. Hyperbole

Hyperbole is a way of writer or speaker makes something sound much bigger and exaggerates than it actually is or to make more dramatic.

Usually it is used as a way of making a writing or expression more creative and humorous.
